- (3) The applicant / authorized person may need to provide draft, layout, demonstration and direct access to the displayed information at the request of the Hong Kong Observatory.
- (4) The authorized person should provide an UPDATE to the Hong Kong Observatory via email to appweb@hko.gov.hk if there are changes in his/her information supplied to the Hong Kong Observatory.
- (5) The Hong Kong Observatory shall have full rights to revoke any granted authorization. Revocation of the authorization shall be considered under but not limited to the following situations:
 - (i) The authorized person has failed to comply with the aforementioned conditions.
 - (ii) The authorized person has supplied any false information in his/her application for the authorization.
 - (iii) The authorized person does not inform the Hong Kong Observatory of the changes in the information supplied.
 - (iv) The Hong Kong Observatory's information re-disseminated by the authorized person is false, incomplete or presented in a misleading way.
- (6) The authorized person should not reproduce or re-disseminate information from the Hong Kong Observatory website after revocation of the authorization.
